Plan Ahead for Spring, Summer Travel

Spring and summer breaks are right around the corner and a great time for families to travel and spend time together.

We hope you'll be able to take all the kiddos with you. The fun and adventure will be a highlight of a foster child's time

in your home. Most importantly, it will allow your kids to feel included and part of the family.

With that in mind, here are a few things to know before you go:

- Connect with your licensing support coordinator at least 30 days prior to travelling if you're heading to another state. You will need a court order.
- If you are unable to take your kids, please arrange for them to stay with a backup caregiver who is listed in your foster care license.
- Send an email to all parties (case manager, licensing support, Guardian ad Litem) to let them know who will be caring for your children in your absence and how to reach you in an emergency. Please include your temporary caregiver in that communication.
- If you need respite care provided by another foster parent, they must be able to provide appropriate bedding and car seats for additional children. Share your plan with Intake and Placement staff so they can ensure all requirements are met and proper payment is made to the temporary caregivers.
- Ensure that your foster children have met and are comfortable with the
 temporary caregivers and their home **before** you leave. Consider having them
 babysit for you in the weeks leading up to your time away or coordinate several
 play dates. This prior introduction will help ensure a seamless transition for the
 child and caregiver, enabling them to have a successful and enjoyable time
 together.
- Make sure the temporary caregiver has the child's necessary supplies (diapers, formula, clothing, medications) and insurance card in case of emergency.
- Set expectations. Let the temporary caregiver know if you'd like them to check in daily or not at all. Some families will relax better knowing their child is having a great time. Other families need a break and will prefer for non-emergency updates to wait until they return home.

And if you are able to help a fellow foster family during the upcoming breaks, please let our placement teams know. Many families will need respite care in the coming weeks. Foster families in Orange, Osceola and Seminole counties who can help are asked to share their availability with their licensing or placement coordinator. Brevard families should notify intake@brevardfp.org.

Foster Care Board Payment Schedule

Foster board and childcare subsidies are issued the second Thursday of the month following the date of service. Below is the reimbursement schedule for the next five months.

- February services reimbursed March 13
- March services reimbursed April 10
- April services reimbursed May 8
- May services reimbursed June 12
- June services reimbursed July 10



Know the Ropes: Placement Checklist

A placement checklist was created in partnership with a group of foster parents to provide guidance for caregivers with new placements. It includes important topics for discussion with case managers to ensure all aspects of the placement of a child in your home are considered. Check it out for your review and use.

Camera and Recording Guidance

The Department of Children and Families recently issued new guidance regarding recording devices. Cameras are no longer required to record. If a camera does record, the footage still needs to be kept for 14 days. Cameras are not allowed in bedrooms or bathrooms.
