Service: Anger Management

Description: Provides parents and teens with successful skills for managing their own stress, preventing escalation, and reducing family conflict. Anger management can be addressed in a group setting or during individual counseling.

If caregivers have substance abuse issues these issues must be addressed, prior to a caregiver being psychologically able to learn anger management skills. Family Partnerships of Central Florida may require a Family Team Conference to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographic: Teens and adults; in group settings or individually.

Goal: Prevent the occurrence or recurrence of child abuse and neglect by building strong families.

Service Providers: A New Perspective, Advanced Psychiatric, Beltran Psychological Services, Coastal Behavioral Therapy, Yellow Umbrella, Caribbean Community Connection, All Family Resource Center, Community Counseling Center of Central Florida, Legacy Behavioral, Optimum Potential Community Services, Serving Children and Reaching Families (SCARF), Transition House

Funding Sources: Family Partnerships of Central Florida

How to Access: Referrals originate through the Dependency Care Manager and Care Coordinator.

Eligibility Criteria: A person must have evidenced, by their behavior, inappropriate anger management behaviors that, as a result, have led or could lead to increased family conflict or child abuse.

Service: Agency for Persons with Disabilities (APD)

Description: APD works in partnership with local communities and private providers to assist people who have developmental disabilities and their families. APD also provides assistance in identifying the needs of people with developmental disabilities for supports and services. APD provides a variety of medically necessary services to persons who are currently enrolled in Florida's four Medicaid waivers; referred to as *waiver tiers*. Services may include occupational and physical therapy, private nursing, mental health counseling, personal care assistance, transportation, companion, behavior therapy, in-home support, adult dental services, and respite care. Three of the waivers have financial caps. The supports and services for persons with developmental disabilities are provided through APD's 14 area offices, throughout the state.

Referral Reason: When people in the community require support in living, learning, and working in their communities.

Demographic: Ages 3 years and above.

Goal: Provide critical services and supports for persons with developmental disabilities to reach their full potential.

Service Provider: Agency for Persons with Disabilities (APD)

Funding Source: APD Waiver Programs State of Florida

How to Access: An individual who has or may have a developmental disability, or their authorized representative, may apply for services at any time by contacting the Agency for Persons with Disabilities website at apd.myflorida.com

Eligibility Criteria: A person must live in Florida, be at least three years old, and have one of the following disabilities that occurred before the age of 18: people severely impaired by Autism, Cerebral Palsy, Spina Bifida, Intellectual Disabilities, Down Syndrome, Prader-Willi Syndrome, Phelan-McDermid Syndrome, and children age 3-5 who are at risk of a developmental disability. Children, ages three to five, who are at risk of being diagnosed with a developmental disability may also be served by APD. APD may provide a free assessment to determine if someone is eligible for services.

Service: Batterer's Intervention/Violence Intervention Program

Description: Batterer's Intervention Program is a psycho-educational group led by trained, professional facilitators. Batterers learn to identify abusive behaviors and are taught to react non-abusively and instead communicate with their partner. These behaviors can be physical or emotional.

If caregivers have substance abuse issues these issues must be addressed, prior to a caregiver being psychologically able to learn how to have non-abusive relationships. Family Partnerships of Central Florida may require a Family Team Conference to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographic: Adults

Goals: A) Increase the batterer's awareness of the effects domestic violence has on children; motivation to stop abusive behavior; capacity for healing and having constructive relationships with their children; and support of their partner's parenting. B) Learn how to problem-solve within their relationships and eliminate the power and control nature of their relationships.

Service Providers: STEPS, The Transition House, A Great Life Services, A No Abuse Program, Advanced Psychiatric Solutions, All Family Resource Center, Beltran Behavioral Health, Central FL Recovery Center, New Way Counseling

Funding Sources: Community providers offer sliding-scale fees. Due to the nature of this particular service, clients respond better to treatment when they pay a nominal fee. Family

Partnerships of Central Florida will also fund a portion of this service once the client's share of the contribution has been determined.

How to Access: Referrals originate through the Dependency Care Manager and Care Coordinator.

Eligibility Criteria: A person must have evidenced, by their behavior, battering or domestic violence that, as a result, have led or could lead to increased family conflict or child abuse.

Service: Behavior Buddy/Behavior Management Associate

Description: Provides support to children in need of both Certified Behavior Analyst services and those typically provided during mentoring activities. Applied Behavior Analysis principles are utilized to ensure a child's challenging behaviors are being addressed and also focus on social skill acquisition and securing more natural supports in the community. Family Partnerships of Central Florida may require a Family Team Conference to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographic: Children and teens

Goals: A) Improve emotional, mental, and functional status of the child or adolescent. B) Increase his/her ability to live safely, attend school, and be an active member in their community environment. C) To increase the likelihood of a successful transition to a family or less restrictive community setting and to increase capacity for independent living, if it is developmentally appropriate.

Service Provider: Brevard Behavioral Consultants, Coastal Behavioral Therapy

Funding Source: Family Partnerships of Central Florida

How to Access: Referrals originate from the Dependency Care Manager and Care Coordinator.

Eligibility Criteria: A person must have evidenced inappropriate behaviors at home, school, or community, and need some behavior management principles but not as much as Certified Behavioral Analysis.

Service: Behavior Management

Description: Behavior management services are used when children have complex needs. These services are intended to maintain the child or adolescent in the home (biological relative/non-relative or foster). These services can be provided by a Masters or bachelor's level Behavior Analyst. Family Partnerships of Central Florida or Brevard CARES may require a Family Team Conference to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographic: Children and teens

Goals: A) Improve the emotional, mental, and functional status of the child or adolescent. B) Increase his/her ability to live safely, attend school, and be an active member in their community environment. C) Increase the likelihood of a successful transition to a family or less restrictive community setting and increase capacity for independent living, if developmentally appropriate. D) Assist the caregiver in acquiring necessary skill sets to meet a child's needs.

Service Providers: Coastal Behavioral Therapy, A Core Connection Services and Consulting, Adapt Behavioral Services, Kinder Consulting, Abilities Unlimited, Behavior Services of Brevard, Monarch Circle

Funding Sources: Family Partnerships of Central Florida, Medicaid

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: A child must have evidenced inappropriate behaviors at home, school, or community. These children have complex or complicated social, emotional, psychological, or behavioral needs that require structured interventions to provide the necessary framework for the child to have ongoing success at home, school, and community.

Service: Bio-psychosocial Assessment/Mental Health Assessment

Description: A review of clinical impressions to provide a provisional diagnosis and develop recommendations needed to establish or support a diagnosis regarding treatment; to assist in the development of or modification to the treatment plan and implementation; and the development of discharge criteria.

Demographic: Children to Adults

Goal: Describe the biological, psychological, and social factors that may have contributed to the child's need for services.

Service Providers: A Core Connection, Allies in Mental Health, Allies in Wellness, A New Perspective, Adapt Behavioral Services, Advanced Psychiatric Solutions, A Better Therapy, ABC Counseling, Aspire Health Partners, B.O.A.T. Brevard Behavioral Consultants, Caribbean Community Connection, Central Florida Recovery, Children's Home Society, Chrysalis Health, Circles of Care, Coastal Behavioral Therapy, Envizion Therapeutic Services, Families First of Florida, Connect America, IMPOWER, Kinder Consulting & Parents Too, Lifetime Counseling Center, Legacy Behavioral Health, Lukas Counseling Company, Meridian Associates, New Way Counseling, Pathways Life Coaching & Support Services, Positive Behavioral Solutions, The Peyton Network, Transition House, Youth Advocate Program

Funding Sources: Family Partnerships of Central Florida, Medicaid

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*.

Service: Child Placing Agency

Description: Agencies that license and manage foster families who act as temporary caretakers for children entering the child welfare system. Such homes include emergency shelter homes, family foster group homes, and specialized foster homes for children with special needs.

Demographics: Ages 0-17

Goal: Foster families provide for the safety and well-being of dependent children, while providing twenty-four hour-a-day room, board, care, and supervision that addresses each child's individual physical, social, emotional, and educational needs.

Service Providers: Family Partnerships of Central Florida, Devereux of FL, One More Child

Funding Sources: Family Partnerships of Central Florida, FL Medicaid

How to Access: All placements must be made through Family Partnerships of Central Florida's centralized Intake and Placement Unit. Placement requests can originate from either the CPI or Dependency Care Manager.

Eligibility Criteria: Placement in a Child Placing Agency foster home requires the child to be in shelter status or adjudicated dependent by the court.

Service: Group Therapy

Description: Group therapy services include the provision of cognitive behavioral, supportive therapy or counseling to individuals or families, and consultation with a family or other responsible persons. Group therapy may also include education, counseling or advising family or other responsible people on how to assist the client. Displays of specific behaviors that require support, education and intervention to assist in improving the overall functioning of a client may include but are not limited to oppositional defiance, truancy, substance misuse, poor anger-management skills, and legal involvement.

The group size limit is up to 10 participants with a mental-health diagnosis and up to 15 participants with a substance abuse diagnosis.

Demographic: All Ages

Goal: Reduce or eliminate maladaptive behaviors, aiding the client in improving social skills so as to better function in his/her community.

Service Providers: A Better Therapy, A Core Connection Services and Consulting, A Great Life Services, A New Perspective Counseling, Adapt Behavioral Services, Advanced Psychiatric Solutions, AMI Kids, All Family Resource Center, B.O.A.T, Central Florida Recovery Center, Families First of FL, Friends of Children and Families, Kinder Consulting, Legacy Behavioral Health, Kids House, North Star Counseling, Optimum Potential, Transition House, Youth Advocate Program.

Funding Sources: Family Partnerships of Central Florida and the Family of Agencies, Medicaid

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*.

Service: Individual Therapy

Description: Working one-on-one with a therapist, youth develop a plan to create positive changes when they are displaying maladaptive behaviors related to their behavioral health disorder and require interventions.

Demographic: Ages 5-17

Goals: A) Enable individuals to function successfully in the community, in the least restrictive environment and to restore or enhance ability for personal, social and vocational life-management services. B) Maximize behavioral self-control or restore normalized functioning and more appropriate interpersonal and social relationships.

Service Providers: A Better Therapy, ABC Counseling, A Core Connection Aspire Health Partners, Abilities Unlimited, Adapt Behavioral, Advanced Psychiatric Solutions Brevard Behavioral Consultants Children's Home Society, Chrysalis Health, Circles of Care, Coastal Behavioral Therapy, Envizion Therapeutic Services, IMPOWER, Kinder Consulting & Parents Too, Lifetime Counseling Ce Lukas Counseling Company, New Way Counseling, Pathways Life Coaching & Support Services, Positive Behavioral Solutions, Allies in Wellness, A Great Life Services, A New Perspective Counseling, Advanced Psychiatric Solutions, All Family Resource Center, Caribbean Community Connections of Orlando, Central FL Recovery Center, Children's Home Society, Circle of Friends, Community Counseling Center of Central FL, Families First of FL, Friends of Children and Families, Happy Healing Growing Process, IMPOWER, Meridian

Funding Sources: Medicaid, Family Partnerships of Central Florida

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Services Coverage and Limitations* handbook and/or Behavioral Health Services.

Service: Mentoring

Description: A short-term, three to six-month service, with clearly outlined goals that provides mentoring sessions in the home or community setting to support the child and/or family in developing skills that will allow them to engage in community-based activities on their own. Provides referrals and coaches families on how to access resources, based on assessed need for economic or financial assistance, child assessment, screening or treatment. Family Partnerships of Central Florida may require a Family Team Conference to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographic: Children 10 and older and teens

Goals: A) Develop social skill acquisition for children and teens by providing them with opportunities to increase their involvement in community activities with children their own age. B) Provide youth with opportunities to increase their age-appropriate, independent living skills. C) Ensure natural, community connections are made for children and families to increase formal and informal support.

Service Providers: Brevard Behavioral Consultants, Coastal Behavior Therapy, Family Advocates of FL, Friends of Children and Families, Mindful Community Solutions, Youth Advocate Program

Funding Source: Family Partnerships of Central Florida

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: A child who has no community connections or supports.

Service: Medication Assisted Treatment

Description: Medication Assisted Treatment is a medication treatment option for opioid based addictions where the primary drug of choice is opioids.

Demographic: 18 and over and parents who are involved in the child welfare system

Goal: To assist the client in achieving sobriety from illicit opioids, development of a support system, assistance with living a drug free lifestyle.

Service Providers: Circles of Care, Specialized Treatment Education and Prevention Services (STEPS), Aspire Health Partners,

Funding Source: Medicaid, grant funded, self-pay

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Individuals served must be Brevard County residents willing to engage and meet program requirements.

Service: Mobile Response Team (MRT)

Description: 24/7 immediate, on-site, crisis response which are flexible and tailored to meet the individual needs of families in Brevard County. It is generally a one-time service but can be utilized more frequently if exception criteria are made.

Goal: Stabilize families in crisis by providing immediate and customized supportive crisis counseling in effort to link to appropriate resources in the community through care coordination.

Demographic: All Ages

Service Provider: FPOCF-Brevard, Devereux-Orange, Osceola, Seminole

Funding Sources: Family Partnerships of Central Florida, Brevard CARES, Central FL CARES Health Systems

How to Access: Brevard-Call the MRT line directly at 321-213-0315, Press Option 1, Devereux-407-839-4357 or call 211

Eligibility Criteria: Must be a resident of Brevard County and in crisis or impacted by familial crisis at the time of request for service.

Service: Adult Mobile Crisis Co-Responder Team

Description: Immediate, on-site, co-responder services available from 8 a.m. -11 p.m. in

partnership with Melbourne Police Department to increase public safety and access to mental health services, in effort to divert from entry into the criminal justice system and emergency department admissions.

Goal: Stabilize individuals in crisis by providing an immediate response to access mental health services and connect individuals with community resources and treatment services for adults who have mental illness, substance use disorders, and co-occurring disorders.

Demographic: Residents of Brevard County within the vicinity of Melbourne

Service Provider: FPOCF

Funding Sources: Family Partnerships of Central Florida, Central FL CARES Health Systems, Melbourne Police Department

How to Access: Onsite Crisis Services-Contact Melbourne Police Department 911. For Care Coordination Services- Contact 321-213-0315, Press Option 2

Eligibility Criteria: Must be a resident of Brevard County who resides in Melbourne and in crisis or impacted by familial crisis at the time of request for service.

Service: Non-Judicial In-home Services

Description: FPOCF Non-Judicial In-home Services uses a Wraparound Family Team Conferencing (FTC) approach to address the needs and strengths of families as well as the Florida Safety Decision Methodology process (FSDM) to divert the family from the dependency system. Wraparound is a planning process that brings together people from different parts of the whole family's life. FSDM is a process that determines the presence of danger threats to a child while in the home. With help from a Diversion Care Coordinator, people within the family's circle work together, coordinate their activities, and blend their perspectives of the family's situation to create desired change and help strengthen children, families, and communities. If multiple services are requested for a family Brevard C.A.R.E.S. may require an FTC to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual. Families decide how often to schedule FTC meetings and can schedule as often as weekly or as infrequently as every 60 - 90 days. The family and/or team members may determine, at any time, that an FTC needs to be convened to discuss new circumstances or information that warrant additional planning.

Demographic: Families with a child who has been determined to be unsafe by the Department of Children & Families

Goals: A) Enable children to safely remain in their own homes whenever possible, while ensuring families have voice in the planning process. B) In incidents where the child is in out-of-home placement, to assist in safely returning the child home.

Service Provider: Brevard-Cares, Orange-Henderson, Osceola-Henderson

Funding Source: Family Partnerships of Central Florida

How to Access: Referrals originate from the Department of Children & Families

Eligibility Criteria: Any family with a child who has been determined to be unsafe has an open investigation with the Department, Prevention case, or a step-down from court-ordered dependency are staffed with the Non-Judicial In-home Services Supervisor to determine if they are willing to participate in the Wraparound process.

Service: Parent Mentoring Services

Description: provides guidance and support to help parents strengthen parenting skills through one-to-one or group sessions. Services focus on parenting skills, parent-child bonding, child development, health, nutrition, home management, connection to resources and problem solving. Services are provided to clients through peer mentoring in a natural environment, via regular home visits from parent mentor trained staff.

Demographic: Adults

Goal: Increase parents' skills to reduce or eliminate the risk of child abuse or neglect.

Service Providers: Adolescent Life Coaching, Advanced Psychiatric Solutions, Brevard Behavioral Consultants, Caribbean Community Center for Attachment and Trauma, Coastal Behavioral, Eckerd Connects, Entrust, Family Advocates of Florida, Resilience Behavioral Health

Funding Source: Family Partnerships of Central Florida

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: A person must have evidenced, by their behavior, a lack of skills in parenting, parent-child bonding, child development, health, nutrition, home management, and/or problem solving.

Service: Parenting Assessment

Description: Comprehensive Assessment of parenting skills and potential risk for neglect and/or abuse. This assessment may include an observation of parent-child interaction. This assessment should be requested when parental risk factors are of concern but not identified by a known maltreatment.

Demographics: Teens and adults

Goal: Assess parental capacities to determine risk; and to identify services that a parent can benefit from in order to improve their parenting abilities.

Service Providers: Coastal Behavioral Therapy, Envizion Therapeutic Services, Journey's end Counseling, Lifetime Counseling Center, Mindway International

Funding Sources: Family Partnerships of Central Florida

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: A person must have evidenced, by their behavior, inappropriate or a lack of appropriate parenting skills that, as a result, have led or could lead to increased family conflict or child abuse.

Service: Parenting Education

Description: Provided to prevent the occurrence or recurrence of child abuse and neglect; increase parents' confidence and competence in their parenting abilities; afford children a stable and supportive family environment; and otherwise enhance child development.

Education may be delivered in a group setting, virtual group setting, or to an individual in their home. If caregivers have substance abuse issues these must be addressed prior to caregiver being psychologically able to learn parenting skills. Family Partnerships of Central Florida may require a Family Team Conference to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographics: Teens and adults

Goal: Empower parents by teaching new skills, increasing the opportunity to raise a safe, independent, and emotionally healthy child.

Service Providers: A New Perspective Counseling, Advanced Psychiatric Solutions, All Family Resource Center, Beltran Psychological Services, Caribbean Community, Coastal Behavioral Therapy, Family Advocates of Florida, Friends of Children & Family, Genesis Family Enrichment, Yellow Umbrella, Transition House, Eckerd Youth Alternatives

Funding Sources: Family Partnerships of Central Florida, Community funding

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: A person must have evidenced, by their behavior, inappropriate or a lack of appropriate parenting skills that, as a result, have led or could lead to increased family conflict or child abuse.

Service: Psychiatric Evaluation

Description: Psychiatric evaluations typically are used at the onset of illness or suspected illness. It may be utilized again if a marked change in mental status occurs, or admission or readmission to an inpatient setting for a psychiatric illness is being considered or occurs.

A comprehensive evaluation investigates the presenting problem; the history of the present illness; previous psychiatric history, physical history, and medication history; relevant personal and family medical history; personal strengths; and a brief mental status examination. This examination concludes with a summary of findings, diagnostic formulation, and treatment recommendations.

Demographic: Ages 6 to adult

Goal: To establish a therapeutic doctor/patient relationship, gather accurate data to formulate a diagnosis, and initiate an effective treatment plan.

Service Providers: Advanced Psychiatric Solutions, Chrysalis Health, Impower, Legacy, Multilingual Psychological Services, Tampa Bay Therapy and Associates

Funding Source: Medicaid, Family Partnerships of Central Florida, Images of Glory, Optimum Potential Community Services, Serving Children and Reaching Families, The Transition House, Caribbean Community Connections of Orlando, Families First of FL, Images of Glory, IMPOWER,

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*.

Service: Psychological Testing

Description: May be used at the onset of illness or suspected illness; identified ASD symptoms, a marked change in status occurs, or if the client is being considered for admission or readmission to a psychiatric inpatient setting. Diagnosis of the mental status or psychological condition of a client is made through the use of standardized testing methodologies. Psychological testing must be provided by an individual practitioner within the scope of professional licensure.

Demographic: Ages 3-17

Goals: A) Determine a diagnosis or assess differential diagnostic impressions. B) Gather additional information and evaluate or redirect treatment efforts.

Service Provider: Advanced Psychiatric Solutions, All Family Resource Center, Dr. Scott Kaplan, Dr. William Eyring, Florida Psychological Specialists, Lifetime Counseling Center, The Transition House, All Family Resource Center, Center for Attachment and Trauma, Central Florida Psychological, Child Development and Diagnostic Center, Monarch Psychological, Multilingual Psychological

Funding Sources: Family Partnerships of Central Florida, Children who have Medicaid can also be referred by their pediatrician to a Medicaid provider.

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*.

Service: Psycho-Social Rehabilitation (PSR)

Description: Development of skills and resources that utilize activities and environmental adaptations for interventions. Help individuals achieve a better quality of life while integrating them into the community. The goals are recovery, community integration, and quality of life. The values are strongly oriented towards client self-direction and encouraging self-determination, dignity and hope.

Demographic: Ages 10-22

Goals: Recovery from mental illness, Personal growth, quality of life, community reintegration, empowerment, increased independence, decreased hospital admissions, improved social functioning, improved vocational functioning, improved physical health, increased involvement in treatment decision, and recovered sense of self.

Service Provider: A Better Therapy, All Family Resource Center, Lukas Counseling

Funding Sources: Medicaid, WellCare, Cenpatico, Magellan, Beacon Health Strategies, Beacon Health Value options

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*. A person must already be engaged in individual counseling with the same provider.

Service: Safety Management Services Team (SMST)

Description: The Safety Management Team provides immediate on-site crisis response and stabilization services to families identified as being at imminent risk of child/children removal or family disruption. The goal of the program is to keep at risk families intact to avoid removal of the children, assist with family engagement of services, provide short-term stabilization services, assess family functioning through a thorough clinical assessment and provide and/or help facilitate access to needed wraparound services to assist the family.

The Safety Management team (SMT) are available 24 hours per day, 7 days per week to families that reside in Brevard County. The Safety Management Services Team works in cooperation with the Florida Department of Children and Families (DCF) investigations staff to screen families for eligibility for SMST services.

Upon notice, SMST will deploy a Clinician to the location of the identified family within (2) hours of the initial request for service. We will then complete an assessment using an evidenced based standardized assessment tool (North Carolina Family Assessment Scale) during the initial on-site visit to create a Crisis and Safety Plan for the family to follow. Results will be shared with the referring party within 24 hours of the response.

We will complete a summary of the visit along with providing identified service recommendations for the family. SMST will remain engaged with the family, to include daily visits and attempt to provide short-term stabilization and support until recommended service providers/case management has made contact with the family who will continue services upon the departure of the Safety Management team.

Demographic: Services are provided to any family identified to be at risk for child abuse or neglect in the Brevard County, Florida area.

Goals: Provide clinical assessment to create a Crisis and Safety Plan to keep families intact to avoid removal of children. Follow up services include short-term family stabilization and support as needed until case management services are in place and SMST can safely discharge the family for a smooth transition to recommend follow up services.

Service Provider: Brevard C.A.R.E.S.

Funding Source: Family Partnerships of Central Florida

How to Access: Working in cooperation with the Florida Department of Children and Families (DCF) investigations staff, DCF Supervisors or approved staff members initiate a call to the SMT

24hr Emergency Response Dispatch line to request a SMT team clinician to respond.

Eligibility Criteria: Services are provided to any family identified to be at risk for child abuse or neglect in the Brevard County, Florida area as referred to SMST by DCF.

Service: Specialized Therapeutic Foster Care (STFC) Level I, Level II, Crisis Stabilization Bed

Description: Intensive treatment services provided to children with emotional disturbances who reside in a state licensed foster home. STFC incorporates clinical treatment services that are behavioral, psychological, and psychosocial in orientation, and are required to enable the child/adolescent to be maintained in the least restrictive setting possible. STFC services are appropriate for long-term treatment and short-term crisis intervention.

Demographic: Ages 0-17

Goal: Enable a child to manage and work towards resolution of his or her emotional, behavioral, or psychiatric challenges in a highly supportive, individualized, and flexible home setting.

Service Provider: Devereux

Funding Source: Medicaid

How to Access: Recommendation for a Specialized Therapeutic Level of Care must be made by the Clinical Review Team.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*.

Service: Specialized Therapeutic Group Care

Description: Therapeutic group care services are community-based, psychiatric, residential treatment services designed for children and adolescents with moderate to severe emotional disturbances. They are provided in a licensed residential group home setting serving no more than 12 children and adolescents.

These services are provided when children and adolescents are ready for step-down from a more restrictive residential treatment program or for those who require more intensive, community-based treatment to avoid placement in a more restrictive residential treatment setting.

Treatment includes provision of psychiatric, psychological, behavioral and psychosocial services to Medicaid eligible children who meet the specified clinical criteria described in this section. Therapeutic group care is intended to provide a high degree of structure, support, supervision,

and clinical intervention, in a home-like setting.

Goal: Provide a therapeutic framework of daily living for children and adolescents.

Demographic: Ages 5-17

Service Providers: Chrysalis, Devereux STGC, St. Augustine Youth Services, FUMCH, The Children's Place at Home Safe, (statewide agencies can be used, as needed)

Funding Sources: Medicaid and FPOCF

How to Access: Recommendation for a Specialized Therapeutic Level of Care must be made by the Clinical Review Team.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*.

Service: Substance Abuse Evaluation and Treatment, Relapse Prevention

Description: Substance abuse treatment programs help address the components of substance abuse by giving the individual a comprehensive treatment plan that eliminates harmful behavior and teaches the skills needed to keep the individual from abusing substances in the future.

Goal: To assist the client in achieving and sustaining sobriety, development of a support system and assistance with living a drug free lifestyle.

Demographic: Teens and adults

Service Providers: ABC Counseling, Lifetime Counseling Center, S.T.E.P.S., All Family Resource Center, Central FL Recovery Center, Chrysalis Health, Impower, B.O.A.T. Transition House

Funding Sources: Family Partnerships of Central Florida, Brevard C.A.R.E.S., Managing Entity: Central Florida Cares, Medicaid

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Client has demonstrated a harmful pattern of overindulgence in drugs or alcohol.

Service: Supervised Visitation (Therapeutic) Dependency Only

Description: Provides a protected visitation and a therapeutic intervention between children and the non-custodial parent so that the child or children benefit as much as possible from the

contact. Visitations assist children in the transition to different family structures, while providing for the safety of the child; actively engages in assisting the non-custodial parent and child to strengthen the bond if it has been interrupted by court process. Visits focus on improving parenting skills. This incorporates understanding and guiding nurturing interactions between the infant or child and their parent.

Family Partnerships of Central Florida may require a staffing and court order to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographic: Parents and children who have a case plan goal of reunification.

Goals: A) Assist children and their families in maintaining or re-establishing relationships that are healthy and safe for the child. B) Improve the child's mental, emotional, physical, and social development. C) Strengthen the parent-child relationship and increase the number of non-custodial parents receiving nurturing parenting training to repair and/or prevent the effects of domestic violence, physical violence toward and/or neglect of children. D) Provide evaluators and treatment professionals with supplemental information for visitation and treatment planning.

Service Provider: A Core Connection, A New Perspective Counseling, Advanced Psychiatric Solutions, Caribbean Community Connection, Center for Attachment and Trauma, Envizion, Family First, Family Advocates of FL, Health Connect, Journey Home, Journeys End, Kelly Lett, Lifetime Counseling, Mindful Community Solutions, Optimum Potential, Pathways Life Coaching, Residing Hope, The Peyton Network

Funding Source: Family Partnerships of Central Florida

Eligibility Criteria: Service is available to any child or children who are not in the care of a parent and would benefit from protected visitation and therapeutic visitation. Therapeutic visitation is a court-ordered service.

Service: Targeted Case Management (TCM) - Children's Mental Health

Description: When children have a mental health disability which requires advocacy and coordination of services to maintain or improve their level of functioning, TCM provides support and linkages to medical and social supports; assistance with accessing or maintaining connections to needed care and service delivery system; and assists in containing or maintaining services to aid in attending self-sufficiency and satisfaction. These services assist the child or adolescent in attaining self-sufficiency and satisfaction in living, learning, work and social environments of their choice.

Demographic: Ages 5-17

Goal: Provide education, support, advocacy, and guidance in obtaining mental health related services to ensure success in the child or adolescent's community setting.

Service Provider: A Great Life, All Family Services, Chrysalis Health, Family First of FL, Family Advocates of FL, Health Connect, Optimum Potential Community Services, Caribbean Community Connections, Community Counseling Center of Central FL, Families First of FL, Legacy Behavioral, Medtrack

Funding Source: Medicaid

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator then routed through the assigned Targeted Case Manager.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health Care Administration's *Community Behavioral Health Overlay Services Coverage and Limitations Handbook*.

Service: Therapeutic Behavioral On-Site Services for Children and Adolescents (TBOS)

Description: Therapeutic behavioral on-site services are used when children have complex needs, such as: when a child or youth has an ICD-9-CM diagnosis or is enrolled in special education program for the seriously emotionally disturbed (SED) or the emotionally handicapped; there is adequate evidence to indicate that the child or adolescent is at risk for a more intensive, restrictive and costly behavioral health placement; or there is adequate evidence to indicate that the child's or adolescent's condition and functional level cannot be improved with a less intensive service, such as individual or family therapy or group therapy.

These services are intended to maintain the child or adolescent in the home (biological or foster) and to meet their treatment needs.

Demographic: Ages 0-17

Goals: A) Improve emotional, mental, and functional status of the child or adolescent. B) Increase his/her ability to live safely, attend school, and be an active member in their community environment. C) Increase the likelihood of a successful transition to a family or less restrictive community setting. D) Increase capacity for independent living, if developmentally appropriate.

Service Providers: Chrysalis Health, Kinder Consulting

Funding Sources: Medicaid

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: Must meet Medical Necessity Criteria established in the Agency for Health

Service: Tutoring

Description: When a child is underperforming academically or has been identified through an Individual Education Program (IEP) or other educational assessment process tutoring service providers will go into the school or home to work with children one-on-one to improve academics, expressive and receptive language, social skills, FCAT performance, and organizational, sensory, and behavioral skills. Formal assessments are completed, and measurable goals are written to guide the tutoring.

Family Partnerships of Central Florida may require a Family Team Conference to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

Demographic: Children and teens

Goal: Improve a student's academic performance and ensure they are meeting educational targets.

Service Providers: Achieve Success, Advanced Psychiatric Solutions, Club Z Tutoring, CogniTutor, Coastal Behavioral, Entrust, Friends of Children and Families, Family Advocates, Grade Potential, In Home Tutoring of Orlando, The Sunshine Method.

Funding Source: Family Partnerships of Central Florida, Title I Schools

How to Access: Referrals originate through the Dependency Care Manager and Brevard C.A.R.E.S. Care Coordinator.

Eligibility Criteria: A student must have evidenced, by their academic performance, that additional support is necessary to achieve or maintain grade-level.

Service: Wraparound Family Team Conferencing/Prevention, Coordination, Advocacy, Resources, Education and Support (C.A.R.E.S.) Model

Description: - The C.A.R.E.S. Model was developed as a seamless continuum of care for children and families committed to promoting prevention and providing the support families require to live successfully after graduating from the program. The C.A.R.E.S. Model uses a Wraparound-Family Team Conferencing (FTC) approach to address the needs of families. The goal of the C.A.R.E.S. Model is to enable children to safely remain in their homes, while ensuring families have access, voice, and ownership in the planning process. Wraparound is a planning and teaching process that brings together people from different parts of the whole family's life to strengthen natural supports and prepare the family for future crisis and/or challenges.

With help from a Care Coordinator, people within the family's circle work together, coordinate their activities, and blend their perspectives of the family's situation to create desired change and help strengthen children, families, and communities. If multiple services are requested for a family, the Care Coordinator will facilitate an FTC to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

The family decides how often they would like to host their FTC meetings; meetings can be held in any safe location determined by the family and include only the individuals chosen by the family. FTC meetings are held monthly, although, life circumstances may occur outside of the FTC and the family or team members may determine, at any time that an FTC needs to be convened to discuss new circumstances or information that warrants additional planning.

Demographic: Families are referred by the Department and Children and Families as deemed appropriate by the Child Staffing Specialists co-located at the Department of Children and Families Service Centers or Family Partnerships of Central Florida's Family of Agencies.

Goals: Enable children to safely remain in their own homes whenever possible, while ensuring families have voice in the planning process.

Service Provider: Family Partnerships of Central Florida - Brevard C.A.R.E.S.

Funding Source: Family Partnerships of Central Florida

How to Access: Referrals originate through Intake and Placement at Family Partnerships of Central Florida 321-752-3226 or with the Child and Family Services Specialist co-located with Child Protective Investigators.

Eligibility Criteria: Any families with children under the age of 18 that are willing to participate in Family Team Conferencing to work together and address needs.

Service: Wraparound Family Team Conferencing/Dependency

Description: Family Partnerships of Central Florida uses a Wraparound Family Team Conferencing approach to address the needs of families in the child welfare dependency system. Wraparound is a planning process that brings together people from different parts of the whole family's life. Additional intensive Care Coordination and Family Team Conferencing is available for children and youth ages 5-18 that have been diagnosed with a behavioral health challenge.

With help from a Care Coordinator, people within the family's circle work together, coordinate their activities, and blend their perspectives of the family's situation to create desired change and help strengthen children, families, and communities. If multiple services are requested for a family, Family Partnerships of Central Florida may require an FTC to ensure the appropriate service is matched with an unmet need and that the service is a cultural fit for the family or individual.

The family decides how often they would like to schedule their FTC meetings; as often as weekly or as infrequently as every 90 days. Life circumstances will occur outside of the FTC and the family or team members may determine, at any time, that an FTC needs to be convened to discuss new circumstances or information that warrants additional planning.

Demographic: Families involved in the Child Welfare Dependency System

Goals: A) Enable children and youth to safely remain in their own homes and/or communities (out of behavioral health placements) whenever possible, while ensuring families and youth have voice in the planning process. B) In incidents where the child is in out-of-home placement, to assist in safely returning the child home and to assist with family preservation.

Service Provider: Family Partnerships of Central Florida - Family Allies

Funding Source: Family Partnerships of Central Florida with additional funding from the Children's Mental Health Expansion Grant awarded to Brevard County by SAMHSA.

How to Access: Referrals originate through the Dependency Care Manager according to annual established priorities.

Eligibility Criteria: Any family that is on a path to reunification should be interviewed to determine if they are willing to participate in FTC. teens in licensed out-of-home care are referred, due to their complex emotional, social, behavioral, and psychological needs. Teens in the Independent Living program often benefit from FTC, as they continue to plan and transition to adulthood.

Services below outline the continuum of treatment options within the Family Partnerships of Central Florida System of Care, ranging from the least to most restrictive levels of care. These services are designed to support families in achieving sobriety and maintaining a substance-free lifestyle while providing safe, healthy, and responsive care for their children.

Service: Behavioral Health Coordinators (BHC)

Description: The Behavioral Health Coordinators (BHC) program is an intervention model for families involved with the Child Welfare/Community Based Care (CW/CBC) system where substance abuse is a contributing factor to abuse and neglect. The BHC performs linkages to behavioral health services to promote substance abuse treatment and recovery with the goal of a safe family environment while serving parents/caregivers involved with the child welfare system whose child is identified to be unsafe (due to parent/caregiver's substance abuse problems).

The Department of Children and Families defines an unsafe, vulnerable child when danger threats are present, and the caregiver does not have the protective capacity to manage those danger threats. The purpose of the BHC Program is to engage families involved in the child welfare system

in behavioral health and substance abuse treatment to keep families together (by preventing identified unsafe children from receiving an out-of-home placement).

An unsafe child status is determined by the child welfare worker with guidance from the Florida Safety Decision Making Methodology Practice Framework. BHC provides adult substance abuse outreach, screening, intervention, and case management. FIS do not function as the primary treatment counselor but moreover serve as a consultant to, and coordinator within the child welfare system. FIS responsibilities are to:

- Accept appropriate referrals;
- Inputs all referrals in the Central Florida Cares Health System (CFCHS) FIS Database tracking system;
- Provide initial screening/assessment;
- Provide the linkage to a community treatment provider for further assessment/treatment as indicated;
- Provide case management;
- Motivate, support and assist in removing barriers to successful engagement in substance abuse treatment;
- Provide report on the progress of individuals referred, via FSFN within 48 hours and monthly progress reports;
- Provide information and recommendations for development and case management of the joint family service plan; and
- Work closely with the child welfare case worker to ensure compatibility between the substance abuse treatment goals and child welfare's plans and interventions for the family.

Demographic: Mothers with infants

Goal: Short-term support to work with client to get them into treatment program

Service Providers:

Funding Sources: Substance Abuse and Mental Health Funding

How to Access: CPI or Case Manager Referral

Eligibility Criteria: Child Welfare involvement and substance abuse disorder

Service: Family Intensive Treatment Team (FITT) Program

Description: FITT serves families where at least one parent has a substance abuse disorder with at least one child 0-10 years old (with a focus on 0–8-year-olds). The family must have been deemed unsafe and demonstrate a willingness to participate in the FITT Program. FITT provides in-home services and offers transportation to appointments. Families have access to 24/7 crisis intervention and resources. Families receive a team approach to treat parental substance

abuse, increase parenting capacity, and address needs of the family. FITT also provides family advocacy and attends Court. FITT Program is comprised of a team of professionals of Clinical Manager/Supervisor, Masters Level Therapist, Case Manager and Peer Support Specialist.

Demographic: Mothers with infants

Goal: Reduce Substance Use/Reunification

Service Providers: Aspire

Funding Sources: TANF/Grant funded

How to Access: CPI or case management referral

Eligibility Criteria: Substance use, at least one child age 8 or younger, taking psychotropic medication as prescribed (if applicable)

Service: Motivational Interviewing (MI)

Description: Motivational Interviewing (MI) is a client-centered, directive method designed to enhance client motivation for behavior change. It focuses on exploring and resolving ambivalence by increasing intrinsic motivation to change. MI is effective in improving substance abuse recovery outcomes by itself, as well as in combination with other treatments. It has been particularly effective in pre-treatment work to engage and motivate clients for other treatment modalities. The overarching goals of Motivational Interviewing are to enhance internal motivation to change, reinforce this motivation and develop a plan to achieve change.

Demographic: Children and families in the community and in the child welfare system

Goal: Progress families through the Dependency system more quickly and effectively with the hopes to reduce recidivism; prevent at-risk families from entering into the child-welfare system

Service Providers: Family Allies; Brevard C.A.R.E.S. **Funding**

Sources: Family Partnerships of Central Florida **How to**

Access: Family Partnerships of Central Florida

Eligibility Criteria: children and families involved in dependency system or receiving preventive services.

Service: Family Navigation Support Team (FNST)

Description: The Family Navigator provides care coordination for at-risk families in Brevard due to

behavioral health and/or substance abuse to assist, teach, and empower families in navigating the child welfare and behavioral health service system to achieve resiliency and recovery.

The Family Navigator will provide community referrals, service authorizations, and crisis intervention linkages to ensure family stabilization. This position also provides mentoring, support, and advocacy to caregivers and children under investigation and engages, links, and monitors the family's adherence to recommendations, including follow up for status reports with service providers.

The Family Navigation Support Team (FNST) works in cooperation with the Florida Department of Children and Families (DCF) investigations staff to screen families for eligibility for FNST services. Once the need has been identified, a Family Navigator will meet with and engage the family at the time of case commencement, or shortly after DCF staff has made initial contact with the family.

The Family Navigator will complete an assessment of the family's needs determined during the initial visit and will provide identified service recommendations for the family. The FNST will also provide recommendations to the DCF staff in regard to appropriate ongoing prevention and diversion support services that are available to the family.

Demographic: Services are provided to any family identified to be at risk for child abuse or neglect in the Brevard County, Florida area.

Goals: Provide up front and timely services to at risk families during the investigative phase by assessing risk factors and engaging in meaningful interactions. Assist families in navigating successful engagement in services and the system of care to keep families intact and avoid removal of children from the home.

Service Provider: Family Partnerships of Central FL - Brevard C.A.R.E.S.

Funding Source: Family Partnerships of Central Florida

How to Access: Working in cooperation with the Florida Department of Children and Families (DCF) investigations staff, DCF Supervisors or approved staff members initiate a staffing with the co-located Family Navigator or Clinical Services Specialist. At that time, a plan is made for the Family Navigator to joint respond with the DCF staff to meet the family and assess for service needs.

Eligibility Criteria: Services are provided to any family identified to be at risk for child abuse or neglect in the Brevard County, Florida area as referred to FNST by DCF.

Service: Neighborhood Partnership Program

Description: Brevard C.A.R.E.S. Neighborhood Partnership Program uses a Wraparound Family Team Conferencing (FTC) approach to address the needs and strengths of families in the

community that do not have an open Department of Children and Families or Family Allies case. The purpose of the program is to allow families the opportunity to reach out for help when the stressors occur to prevent any potential abuse, abandonment or neglect of their children. Referrals are also accepted from various community providers who identify a family that may be in need of assistance. Wraparound is a planning process that brings together people from different parts of the whole family's life. With help from a Neighborhood Partnership Care Coordinator, people within the family's circle work together, coordinate their activities, and blend their perspectives of the family's situation to create desired change and help strengthen children, families, and communities. If multiple services are requested for a family, Brevard C.A.R.E.S. utilizes the Family Team Conferencing process to ensure the appropriate services are matched with an unmet need. The family decides how often they would like to schedule their Family Team Conference meetings; as often as weekly or as infrequently as every 60 - 90 days. Life circumstances will occur outside of the Family Team Conference and the family or team members may determine at any time that a Family Team Conference needs to be convened to discuss new circumstances or information that warrants additional planning. We will be targeting families in the following areas: 32907, 32935, 32922, and 32780 zip codes.

Demographics: Entire families with children under the age of 18.

Goal: To provide care coordination, advocacy, resources, education and support to Brevard County Families in need of services and supports to safely maintain their children in their home.

Service Providers: Family Partnerships of Central Florida - Brevard CARES

Funding Sources: Family Partnerships of Central Florida

How to Access: Families or Community Providers can call our intake line at 321-866-1654.

Eligibility Criteria: Any family with a child under the age of 18. Family cannot have an open DCF or Family Allies case. Family must live in the following zip codes 32907, 32935, 32922, 32780.

Service: Brevard Behavioral Health Expansion (BBHE) Services

Description: The BBHE Grant provides an extension of preventative services for families at risk of becoming further involved with the child welfare system, by offering additional resources and support to meet various needs of the families.

Service: Parent Child Interaction Therapy (PCIT)

Description: PCIT is a dyadic behavioral intervention for children ages 2-7 years and their caregivers. PCIT focuses on decreasing externalizing child behavior problems (e.g., defiance, aggression), increasing child social skills and cooperation and improving the parent-child attachment relationship. It teaches parents traditional play-therapy skills to use as social reinforcement of positive child behavior and traditional behavior management skills to decrease negative child behavior. Parents are taught and practice these skills with their child in a playroom while coached by a therapist. The coaching provides parents with immediate feedback on their use of the new parenting skills, which enables them to apply the skill and master them rapidly.

Description: Child Parent Psychotherapy (CPP) is a treatment for trauma-exposed children aged 0-5. Typically, the child is seen with his or her primary caregiver, and the dyad is the unit of treatment. CPP examines how the trauma and the caregivers' relational history affect the caregiver-child relationship and the child's developmental trajectory. A central goal is to support and strengthen the caregiver-child relationship as a vehicle for restoring and protecting the child's mental health. Treatment also focuses on contextual factors that may affect the caregiver-child relationship (e.g., culture and socioeconomic and immigration related stressors). Targets of the intervention include caregivers' and children's maladaptive representations of themselves, each other, interactions, and behaviors that interfere with the child's mental health. Over the course of treatment, caregiver and child are guided to create a joint narrative of the psychological traumatic event and identify and address traumatic triggers that generate dis-regulated behaviors and affect. CPP directly provides services to children/adolescents and addresses the exposure to trauma, internalizing and externalizing symptoms, and/or symptoms of posttraumatic stress disorder (PTSD).
